## **Tribute to Dr. Colleen Stanton**

# Dr. Colleen Stanton (March 9, 1956 - December 16, 2021)

passing of our past, longtime and dedicated Ontario Healthy Schools Coalition member, Dr. Colleen Stanton.



Colleen and her husband, Bob Harper, were actively involved with the OHSC for at least 14 years—serving on our Core Steering Committee (CSC) from approximately 2006 until the fall of 2019. Colleen and Bob were inseparable and contributed a valuable combination of Colleen's public health promotion perspective and Bob's education sector perspective. Colleen's particular interest was in how to integrate "Health and Well-being" into the education system at the provincial, regional (school board), and local (school) levels. She was a guest speaker with Bob at the 2006 OHSC Annual Forum in York Region and spoke about "A Systems Approach to Healthy Schools." This was new thinking at the time and has since become mainstream. Some of Colleen's other OHSC work included: consistent participation in CSC and OHSC meetings, providing feedback on OHSC draft correspondence and position papers, contributing to strategic planning (2007 & 2018), and being lead author with Bob of our OHSC response to the Ministry of Education regarding Education Funding. Her doctoral research was on "A Health Promoting Continuous Learning Sustainable Education System," where she examined three education system environments—leadership, culture of continuous learning, and interrelatedness of work and life [see https://tspace.library.utoronto.ca/handle/1807/68213]
